

PACIFIC WEST FOOTBALL FEVER CONTEST

Terms and Conditions:

1. The "FOOTBALL FEVER CONTEST" ("Contest") is organised by Pacific West Foods (M) Sdn Bhd ("the Organiser") in collaboration with NTUC FairPrice Co-operative Limited (the "Collaborator").
2. This Contest shall commence from 3rd April 2018 to 7th July 2018 ("Contest Period").
3. The Organiser reserves the right to modify, postpone, re-schedule and/or extend the Contest Period and/or cancel/terminate the Contest at any time without giving prior notice.
4. This Contest is open to all Singaporeans and permanent residents of Singapore, currently residing in Singapore, aged 18 years old and above. ("Participants")
5. The representatives, employees, servants and/or agents of the Organiser and the Collaborator (including their respective affiliated and associate companies) and their immediate family members are not eligible to participate in this Contest.
6. The Organiser reserves the right to exclude and/or disqualify Participants who do not fall within the category of Participants and/or who are in breach of the Contest Rules and Regulations.
7. Contest eligibility: To qualify for the Contest, Participants are required to purchase minimum two [2] packets of Pacific West products from any NTUC FairPrice outlets in an original single printed receipt during the Contest period.

8. Submission of Entries via WhatsApp

Participants are required to snap a photo of the original receipt(s) detailing Contest Name ("PACIFIC WEST FOOTBALL FEVER"), Participant's Name, NRIC No., Contact No., Address, Email Address & Outlet Name in the picture caption and send to +65 8464 9625. Participants will receive a WhatsApp acknowledgment.

9. Submission of Entries by Postage Mail

All entry form(s) must be completed legibly and attached together with the original single printed receipt as a Proof-of-Purchase ("POP"), delivered as ordinary mail. Any other means of delivery will be automatically disqualified. The Organiser will not be responsible for any non-receipt of postal deliveries. Proof of postage is not proof of receipt.

10. Multiple entries will be accepted, provided they are attached together with a valid POP receipt. Each POP receipt can be submitted only ONCE. Illegible entries with defaced POP receipts will be automatically disqualified.
11. All entry form(s) received by the Organiser during the Contest period that are complete, if approved by the Organiser, will be serialised according to the POP Table based on the POP submitted [each a "Qualified Entry" and collectively the "Qualified Entries"].

12. PRIZES

Grand Prize (Total 1 winner)

Winner shall be entitled to receive a travel voucher worth SGD3,000 from Holiday Tours & Travel Sdn. Bhd. and exclusive Pacific West FOOTBALL FEVER merchandises.

Consolation Prize (Total 30 winners)

Winner Selection

At the end of the Contest Period, Eligible Entries will be selected as Potential Winners in accordance with the selection process below ("Potential Winners"). The following is the selection process adopted to determine the Potential Winners:

Each Eligible Entries will be assigned a random serial number. The total count of serial numbers received at the end of the Contest Period will be divided by one hundred and fifty (150) to short-list the Potential Winners for the contest. All the serial numbers selected after division would be the closest lower whole number e.g. if there are a total of 1234 serial numbers at the end of contest, the total serial number will be divided by 150 and rounded to the closest lower whole number, i.e. 8. The Potential Winners would be the one who own the random assigned serial number fall on the sequence of 8, i.e. 8, 16, 24, 32 The Organiser reserve the right to change the winner selection method at its sole discretion.
